Women in Cardno (WiC) is Cardno's gender equality program. One of the five key goals of the program is to provide a program of work to understand and present recommendations to address any GPG. The WiC program has developed a strategy that will communicate and educate managers and employees on the GPG. Additional strategies to maintain the focus on GPG and the potential for it within Cardno involve the delivery of Unconscious Bias training (focused on Managers of people but available for all employees), HR guidance to managers regarding starting salaries, annual salary reviews and salaries on promotion (ensuring that anomalies are not created and all salaries are looked at with a comparison view of like for like employees.)

As above, our Global Workplace Behaviours training module was rolled out in 2017 and is now a mandatory course. This training is monitored for completion rates and followed-up where required. This training encapsulates our Global Workplace Behaviours training, and particularly the areas of sexual-based harassment and discrimination.

In 2017, Cardno ran our biennial employee engagement survey. The survey asks employees to respond to the following questions on a five point likert scale (from strongly disagree to strongly agree). The questions and their scores are: Bullying/harassment is not tolerated in my Business Unit and the Cardno group (4.3 out of 5), Sexual harassment is not tolerated in my Business Unit and the Cardno group (4.5 out of 5), and Discrimination of any kind is not tolerated in my Business Unit and the Cardno group (4.4 out of 5). For this survey and the preceding four surveys, these questions have always been rated in the top ten, indicating a global level of agreement from staff that these negative behaviours are generally not present in our business. Comments in relation to bullying, discrimination and harassment are treated seriously in the survey process and highlighted to the CEO, Global HR Manager and General Manager for action.

The following questions were also added to provide a more holistic picture: Cardno staff treat all employees with respect regardless of differences or position (4 out of 5) and The Cardno work environment is inclusive (3.9). These scores are also very high and along with comments from staff provide us with the insight to build our inclusion programs. The Employee Engagement survey is run on a biennial cycle and will be conducted again in 2019.
